Tax Setup










Value Added Tax (VAT) is a consumption tax added to a product's sales price. It represents a tax on the "value added" to the product throughout its production process.

Regular VAT for Chile is 19%, although there are products and services with an exempt condition.

In order to calculate this tax, it is required the definition of Tax Jurisdictions, Tax Areas and Tax Group Codes.
